1. Who We Are

2. What Personal Data We Collect

We may collect personal data, including:

- Name
- Address
- Email address
- Telephone number
- Property details
- Enquiry information
- Identification and compliance information (where required)
- Financial and transactional information
- Website usage data (cookies, IP address, browser type)

We only collect data that is necessary and relevant.

3. How We Collect Your Data

We collect data when you:

- Complete a form on our website
- Register as a buyer, seller, landlord, or tenant
- Contact us by phone, email, or in person
- Use our website
- Engage with our services

4. Why We Use Your Data (Lawful Basis)

We process your data under one or more of the following lawful bases:

- **Contractual necessity** – to provide estate agency and property management services
- **Legal obligation** – including AML, Right to Rent, and regulatory compliance
- **Legitimate interests** – to run and improve our business
- **Consent** – for marketing communications (where applicable)

5. How We Use Your Data

Your personal data may be used to:

- Respond to enquiries
- Arrange viewings and valuations
- Manage property sales and lettings
- Carry out referencing and compliance checks
- Communicate with you throughout a transaction
- Manage accounts and record-keeping
- Send marketing communications (with consent)

We do **not** sell your data to third parties.

6. Who We Share Your Data With

We may share personal data with trusted third parties where necessary, including:

- Solicitors and conveyancers
- Referencing agencies
- Mortgage advisers (with your consent)
- Contractors and service providers
- Regulatory bodies and local authorities
- HMRC or other government bodies where required

All third parties are required to process data lawfully and securely.

7. Data Storage & Security

We take appropriate security measures to protect your personal data, including:

- Secure cloud-based systems
- Password-protected access
- Restricted access based on role
- Secure document storage
- Staff training on data protection

8. How Long We Keep Your Data

We retain personal data only for as long as necessary, including:

- Sales and lettings records: up to **6–7 years**
- AML records: **5 years**
- Financial records: **6 years**
- Marketing data: until consent is withdrawn

Data is securely deleted once it is no longer required.

9. Your Data Protection Rights

You have the right to:

- Access your personal data
- Correct inaccurate or incomplete data
- Request deletion (where applicable)
- Restrict processing
- Object to processing
- Data portability
- Withdraw consent at any time
